### BENCHREST NEWS

#### RBA Sanctioned Rimfire BEGINNING JANUARY 28, 2006

If you shoot benchrest or would like to join the sport be sure to note the following changes.

1. Benchrest (rimfire and centerfire) will shoot the fourth Saturday of each month beginning January 28 2006. Rimfire matches begin at 9am, centerfire begins after the rimfire awards, approximately 12:30pm. The schedule change was made to eliminate a conflict with the Emerald Empire Club

match schedule and allow members of both clubs to shoot at one another's sanctioned matches.

2. Rimfire benchrest is now sanctioned by the Rimfire Benchrest Association (RBA). RBA affiliation will allow our members to compete with shooters nationwide and may attract more Oregon shooters to shoot our benchrest events. We have asked for sanctioned matches for January through July.

3. For now, we plan to shoot in the unlimited class only. Any rifle can shoot in unlimited but will be competing against the unlimited rifles. Do not let that scare you away! "Unlimited" means any rifle/sight combination that exceeds 10.5 pounds. While that includes the highly specialized BR rifles, it also includes many fine factory rifles. If we get enough interest in the Sporter and 10.5 pound classes, we can change things to meet their needs. We are planning many challenging events for the non-sanctioned shooting days, including 100-yard rimfire. Yes, that little old 22LR will easily shoot 100; just ask the Brits; they shoot 200-yard matches!

Clarke McLean is the new director of the rimfire benchrest program, freeing up Paul Soward to concentrate on centerfire benchrest. Many thanks to Paul for his good works with rimfire.

Clarke brings considerable shooting and administrative experience to our program. He recently moved to Salem from Montgomery, Alabama, where he competed and ran matches in PPC, Military Highpower, and three rimfire benchrest programs. Clarke made the mistake of telling us he was retired so we intend to load him up with plenty of things to do.

Rimfire 22LR benchrest is a national and international sport. If pursuit of extreme accuracy is your game or you would like to join the sport please come out to our shoots. ## PURPOSED CHANGES TO THE ARPC CONSTITUTION

(PURPOSED CHANGES TO THE AMENDED & APPROVED MAY 9, 1994 CONSTITUTION)

BLACK=EXISTING • RED=NEW • RED=TO-BE-DELETED

### ARTICLE I - NAME

The name of this organization shall be the Albany Rifle and Pistol Club (~~the Club~~) hereafter known as "ARPC" and its mailing address shall be ~~post office box 727, Albany, Oregon.~~

### ARTICLE II - OBJECTIVE

The objective of this organization shall be ~~training and the encouragement of organized rifle, pistol and shotgun-pistol shooting among private citizens and law enforcement personnel of the United States, resident in our community, while encouraging with a view toward a better knowledge, on the part of such citizens of the safe handling, and proper care of firearms; and as well as improved marksmanship. It shall be our~~ Further, it is our objective and purpose to ~~forward the development of those~~ characteristics of honesty, good fellowship, self-discipline, team play and self-reliance which are the essentials of good sportsmanship and the foundation of true patriotism.

### ARTICLE III - MEMBERSHIP

(A) **TYPES OF MEMBERSHIP:** There shall be ~~three~~ five types of membership ~~which shall be known as~~ Active members: Annual, Life, and Endowment, Family, Junior and Honorary members. ~~The requirements as to eligibility shall be the same as those for the National Rifle Association membership.~~

(B) **ELIGIBILITY.** Any resident of the United States ~~17 years of age or over~~ may become a member of this organization ~~upon vote of the Executive Committee~~ after subscribing to the following pledge, and upon payment of appropriate ARPC membership ~~the usual initiation fees and dues.~~ The pledge of the Albany Rifle and Pistol Club ~~and the National Rifle Association of America~~ is as follows:

#### THE PLEDGE

I certify that I am a resident of the United States of America and that I am not a member of any organization or group which has as any part of its program the attempt to overthrow the Government of the United States or any of its political subdivisions by force or violence; that I have never been convicted of a crime of violence and if admitted to membership I will faithfully endeavor

to fulfill the obligations of good sportsmanship and good citizenship.

(C) **BENEFITS AND DUTIES:** All members in good standing shall have the following privileges:

1. The use of ~~using~~ the facilities of ARPC ~~the Club~~ following ~~under current rules and the regulations and directions issued by the proper authorities.~~

~~Active members in good standing shall have the privilege of-~~

2. Competing for places on the various teams which will represent ~~ARPC the Club~~ in official inter-club competition.

~~Active members in good standing shall have the privilege of-~~

3. A voice and a vote ~~of the ballot~~ in all matters pertaining to the activities and welfare of ARPC as defined herein. ~~the Club except such matters of administration as are delegated by this Constitution and Bylaws or subsequently by proper action of the membership to the Executive Committee, special committees or Club officers.~~

It shall be the duties of all members ~~to conduct themselves at activities in a manner becoming to the true sportsman and citizen;~~ to observe the rules and regulations of ARPC. Further, to conduct themselves ~~the Club and the National Rifle Association of America pertaining to competition and in a safety and responsible manner, displaying good sportsmanship, fair play to assist the officers of the Club in maintaining proper order, discipline, safe conduct and fair play,~~ and to promptly report to the Club officers any infractions of rules by members or visitors which may reflect poorly on ARPC. ~~result in danger to the persons, property, or good repute of members, or of the Club.~~

No member will be considered to be in good standing who is more than thirty days in arrears in the payment of dues or who has ~~been suspended,~~ by proper action of the officers of ARPC. ~~the Club, or of the National Rifle Association, been suspended from privileges of membership.~~

### ARTICLE IV - MEMBERSHIP FEES DUES

(A) **INITIATION FEE.** All new members (except for endowment, honorary and junior membership) shall pay an initiation fee of twice the annual fee.

(B) **ANNUAL MEMBERSHIP DUES:** The members annual dues shall be established by the Executive Committee and put to a vote for approval by a majority of those present at a meeting of the members called for that purpose, provided the voting active members are members in good standing. ~~legally competent to transact business at a meeting called for that purpose.~~ Annual members must be at least 18 years of age.

(B) (C) **LIFE MEMBERSHIP:** ~~All past life memberships issued by ARPC the Club shall continue to be valid life memberships.~~ Life memberships shall be open, upon decision of the Executive Board, to members in good standing for the past 2 years. ~~immediate past two consecutive years until April 1, 1995 when the membership requirement will become three consecutive years.~~ The Life membership fee shall be \$1,000 or 20 times the annual dues, whichever is greater. ~~fee shall continue to be \$200 or ten times the annual dues, whichever is greater until April 1 1995 when the life membership fee will increase to \$500.00.~~

All money received from life memberships shall be maintained in a separate account and used solely for the purpose of shooting range acquisition, construction or improvements.

(C) (D) **ENDOWMENT MEMBERSHIP:** Endowment memberships may be granted by the ARPC Executive Board ~~the Club to members in good standing.~~ for the immediate past three consecutive years. The Endowment membership value fee shall be at least ten (10) ~~five (5) times the Life Membership fee dues.~~

~~All money received from endowment memberships shall be maintained in an account and used solely for~~

~~the purpose of shooting range acquisition, construction or improvement~~

Endowment membership shall be commemorated by special permanent recognition as determined by the Executive Committee.

(D) (E) **HONORARY MEMBERSHIP:** Honorary membership may be granted by ARPC ~~the Club~~ in the following manner: Nomination by the Executive Board ~~Committee~~ and elected ~~ion~~ to honorary membership by the members as a whole. Honorary membership is ~~limited to being~~ awarded as recognition of a special benefit or of service to ARPC. ~~the Club and in conformity with the Articles and purposes of the Club.~~ Honorary membership is non-voting and is not ~~does not make such person~~ eligible to be elected as a Club officer. ~~An honorary member may also hold active membership upon meeting active membership requirements.~~

(E) (F) **FAMILY MEMBERSHIPS:** Will be granted to a family unit (Husband/Wife and children under the age of 18). The fee for such a membership will be 1-1/2 times the annual fee. Each family membership will have 1 vote. Work bond for a family membership will be 1-1/2 times the annual member requirement. All persons under the age of 18 must be accompanied by an adult member.

(G) **JUNIOR MEMBERSHIP:** Are available to juniors under the age of 18 who are involved in shooting activities at ARPC. The annual Junior fee is \$5. All junior members will be supervised by an adult member.

**ARREARS:** No member of ARPC ~~the Club~~ shall be eligible to vote or enjoy any privileges or benefits of the ARPC Club ~~so long as such member is who is not in good standing.~~ in arrears in payment of his dues.

### ARTICLE V - MEETINGS

(A) **ANNUAL MEETINGS:** The annual meeting of ARPC ~~the organization~~ shall be held in ~~on the second Monday of~~ month of November in each year. ~~If the annual meeting shall not take place at the time fixed, it shall be held within a reasonable time thereafter and the officers shall hold over until their successors shall have been elected.~~

(B) **REGULAR MEMBERSHIP MEETINGS:** ~~The A regular membership business meetings of ARPC the organization for the transaction of ordinary business shall be held at least once in each quarter of the calendar year to conduct business at such time and place as may be fixed by the Executive Board Committee.~~

(C) **SPECIAL MEETINGS:** A special meeting of ARPC ~~the organization~~ may be held at any time upon the call of the President or upon the call of the Executive Board ~~Committee~~ or upon demand in writing, stating the object of the proposed meeting, and signed by not less than 20% of the active members in good standing. Notice of the time, place and object of any special meeting shall be given all officers and members in good standing in writing by United States mail not less than ~~fifteen seven~~ days prior to the date fixed for the holding of the meeting. The place of such special meeting shall be fixed by the Executive Board. ~~Committee or by the President if the Executive Committee is unable, or fails, to act.~~

(D) **QUORUM:** No less than 20 members in good standing, including the Executive ~~Board Committee,~~ shall constitute a quorum at any meeting.

### ARTICLE VI - EXECUTIVE COMMITTEE

(A) **ELECTED OFFICERS:** The officers of ARPC ~~the organization~~ shall be a President, Vice President, Secretary, Treasurer, Chief Instructor and Executive Officer who, acting together, shall constitute the Executive ~~Board Committee.~~ They shall be elected by a majority vote ~~by ballot~~ of the active members in good standing present at the annual meeting of ARPC ~~the organization.~~ They shall hold office for one year. ~~or until their successors are elected. The offices of Secretary and Treasurer may be combined.~~

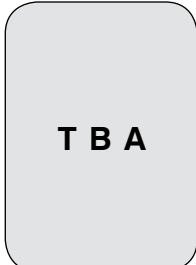

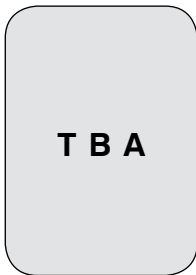

have general supervision, and control of all the activities, and financial responsibility of ARPC. of the organization:

(C) **MEETINGS:** Meetings of the Executive Committee Board shall be held at least regularly not less frequently than once in each quarter of the calendar year at such time and place as the Committee Board may determine. Special meetings may be held at any time on the call of the President or on demand, in writing to the Secretary, by three members of the Committee Board.

(D) **QUORUM:** Four members of the Committee Board shall constitute a quorum.

(E) **RESIGNATION:** Resignation of any officer may be accepted by a majority vote of the remaining members of the Executive Committee Board.

(F) **VACANCIES:** A vacancy in the Executive Committee Board may be filled by a majority vote of the remaining members of the Committee Board. However, if more than one vacancy exists, a special meeting of the organization shall be called and new officers shall be elected to fill the vacancies until the date of the next annual meeting as provided in paragraph (A) above.

#### ARTICLE VII - DUTIES OF OFFICERS

(A) **PRESIDENT:** The President shall preside at all meetings of the organization and of the Executive Committee Board. He shall be a member ex-officio of all regular and special committees and shall perform all such other duties as usually pertain to his office.

(B) **VICE PRESIDENT:** The Vice President shall perform the duties of the President in his absence or at his request.

(C) **SECRETARY:** The Secretary shall ~~conduct all of official correspondence pertaining to the proper preparation and forwarding of all reports required by the National Rifle Association and by the Director of Civilian Marksmanship\*, notify the members of the Executive Committee Board of all meetings and notify all members of regular, special and annual meetings as required in Article V;~~ keep a true record of all meetings of the Executive Committee Board and of the organization and have the custody of the books and papers of the club, except the Treasurers books of account. ~~All applications for membership in the club shall be made to the Secretary, who shall be responsible for the collection of all fees and dues, remitting the same to the Treasurer, who will properly receipt therefor.~~

(D) **TREASURER:** The Treasurer shall have charge of all funds of ARPC the organization and place the same in such bank or banks as may be approved by the Executive Committee Board. Such money shall only be withdrawn by check/voucher signed by the Treasurer or, in unusual circumstances, the President for the payment of such bills as have been approved by the Executive Committee Board. ~~The Secretary shall deliver to the Treasurer a receipt for all such checks, including a list of the names of the members for whom dues are being paid and the dates covered by the membership fee.~~ The Treasurer shall keep an accurate account of all transactions and render a detailed report with vouchers at any meeting of the Executive Committee Board when requested and an annual report to the organization at its annual meeting.

(E) **CHIEF INSTRUCTOR:** The Chief Instructor shall have charge of all ARPC arms instruction with authority to appoint his assistants. He shall contract no bills without the authorization of the Executive Committee Board.

(F) **EXECUTIVE OFFICER:** The Executive Officer shall ~~have charge~~ oversee of the ranges and shooting disciplines of ARPC the Club, the printing of score cards, the arranging of competitions, etc. He shall have the authority to appoint his assistants. He shall contract no bills without the authorization of the Executive Committee Board.

#### ARTICLE VIII - SUSPENSION OR EXPULSION

(A) **OFFICERS:** Any officer may be removed by a two-thirds vote of the members in good standing present at any special meeting called for this purpose. Reference Article V Section C. No vote on suspension or removal may be taken unless at least fifteen days notice in writing shall have been given to the officer of the reasons for his removal, and of the time and place of the special meeting at which such ballot of his removal is to be taken. At such special meeting the officer shall be given a full hearing on the written charges. No additional charges may be presented or considered at this meeting without the

expressed consent of the accused.

(B) **MEMBERS:** Any member may be suspended or expelled from the organization for any cause deemed sufficient by the Executive Committee Board by a two-thirds affirmative vote of the members of the Board Committee present at any regular or special meeting. No vote on suspension or expulsion may be taken unless at least fifteen days notice in writing shall have been given to the member of the charges preferred, and of the time and place of the meeting of the Executive Committee Board at which such charges will be considered. At such meeting the member under charges will be accorded a full hearing on the written charges. No new charges may be introduced or heard at this meeting without the expressed consent of the accused.

(C) **CHARGES:** Charges against any officer or member may be preferred by any member in good standing. They shall be in writing, clearly stating the facts relied upon and accompanied by all affidavits or exhibits which are to be used in their support. Such charges shall be filed with the Secretary who will immediately notify the President. The President will call a meeting of the Executive Committee Board to hear the charges. The Secretary will give at least fifteen days notice of the meeting to each member of the Executive Committee Board and the accuser and to the accused. Such notice shall be in writing and will include a true copy of the charges and of the supporting affidavits and exhibits.

(D) **APPEAL:** Any member suspended or expelled by the Executive Committee Board may appeal to the full membership of the organization. Such appeal shall be made to the Secretary in writing, who will notify the President. The President will call a special meeting of the organization for the purpose of acting on the appeal. The Secretary shall give at least fifteen days notice in writing to all members of the organization in good standing the date, time, place and reason for such special meeting. At the meeting of the full Club the Secretary will read the original charges, the supporting affidavit, and will read or display the accompanying exhibits, and will read the minutes of the special meeting or the Executive Committee Board at which the charges were heard and action taken. A full hearing will be given the accuser and the accused. A vote will be taken by ballot of the members in good standing present and two-thirds vote shall be required to reverse the action of the Executive Committee Board.

(E) **TESTIMONY:** All testimony at hearings on charges against officers or members shall be under oath. The President or other presiding officer will swear the witnesses who give verbal testimony. Affidavits or expositions sworn before a notary public or other officer authorized by law to give oaths in court proceedings shall be acceptable as evidence.

(F) **NRA:** Any official or member of the organization who has been suspended or expelled by the National Rifle Association of America shall automatically stand suspended or expelled from this organization immediately upon receipt of official notice by the Secretary of this organization from the Secretary of the National Rifle Association.

#### ARTICLE IX - RULES OF ORDER

All meetings of ARPC the Club and of the Executive Committee Board will be conducted in accordance with Roberts Rules of Order. ~~as condensed and approved by the National Rifle Association of America.~~

#### ARTICLE X - AMENDMENTS

Amendments to this Constitution may be introduced by any active member, in good standing, of ARPC the organization at any regular meeting or special meeting called for the that purpose. The Executive Board will review and make recommendations to the membership. ~~Proposed amendments must be submitted to the National Rifle Association for approval. After approval by the NRA, Upon recommendation of the Executive Board the amendment(s) will be acted upon by ARPC the Club membership at a regular meeting or a special meeting called for that purpose. A copy of the proposed amendment (s) will be sent to each club member by United States mail or personally delivered at least ten days prior to the meeting. A majority vote of the active members present will be necessary to approve any amendment (s).~~

#### ARTICLE XI - DISSOLUTION

In the event ARPC this organization is dissolved or discontinued, either by act of the Corporation or by operation of law, the assets of the organization shall be transferred to an NRA affiliated shooting range or Gun Club in the State of Oregon Linn County, a

~~municipal corporation of the State of Oregon, for continuance so long as is practicable in the same endeavor as has been carried on in the past and in any event as a park or recreation area. In the event said county cannot accept said assets, the County Court of the State of Oregon for the County of Linn is hereby granted the power to appoint a charitable corporation or corporations to receive the assets of this corporation in whole or in part to best serve the interests and purposes as set forth in the Articles and Bylaws of this organization;~~ provided, however, that in no event shall any member of this organization derive a profit from being a member of this organization or receive any part of the assets of the corporation upon dissolution or distribution thereof pursuant to this Article.

#### ARTICLE XII - BYLAWS

ARPC The Club, by a majority vote of those present, shall have the power to create and/or amend procedures for the conduct of meetings, committees and competitions not in conflict with this Constitution. These procedures shall be known as Bylaws.

#### ARPC BYLAWS

(Amended & Approved May 9, 1994)

(A) **AGENDA:** An agenda for each ARPC Club meeting, including an opportunity for business from the floor, shall be created by the President. ~~and approved by the Executive Committee.~~

(B) **DUES AND MEMBERSHIP:** ~~All new memberships shall be reviewed by the Executive Board Committee and approved or disapproved by a majority vote.~~ Notification of annual dues shall be given to members no later than March 15 of each year.

(C) **PAYMENT OF FEES, BILLS AND DEBTS:** No obligations, fees, bills, or debts under \$100.00 will be incurred by any Club member except upon approval of the President. No debts shall be incurred beyond \$100.00 except upon approval of a majority of the Executive Board Committee.

(D) **GOALS:** The Executive Board Committee shall develop yearly and long-term plans to include proposed projects, range improvements and shooting events. Such plan shall be presented to the membership in a timely manner early in each calendar year.

(E) **ELECTION OF OFFICERS:** The Executive Board Committee shall establish a Nominations Committee of three which will be charged with the responsibility of securing nominations for officers as provided in the Constitution. Such nominations shall be presented to the membership one month prior to any election.

Nominations shall also be accepted from the floor from any member in good standing prior to the annual election.

(F) **PROGRAM DIRECTORS:** The Executive Board Committee shall approve, from the membership, a director for each activity. These directors shall be responsible for the development and continuation of varied the various shooting activities of ARPC the Club.
