

ALBANY GUN & SPORTSMAN SHOW RULES AND INFORMATION

March 7th & 8th, 2026

Rules

1. All Federal, State and Local laws must be obeyed at all times.
2. All gun show firearm transactions are to take place **INSIDE** the gun show building with either FFL transfer Form 4473 or Private Party Transfer Form OSP-WBBN2000 (11/13) (White Private Party Form) including background check approval through Oregon State Police Firearms Unit. **NO EXCEPTIONS.**
3. ***Failure to follow all firearm transfer regulations will result in removal from the show and/or criminal charges.***
4. To prevent accidental discharge, **NO** loaded firearms are allowed in the gun show, including persons with concealed handgun licenses. **Exception- armed security provided by show management or law enforcement officers.**
5. **All** firearms must have magazines removed and actions plastic zip tied open - rendering them inoperable to ARPC show specifications. This includes firearms in glass cases. Ties with specific colors will be supplied by the show indicating which guns belong to vendors (White ties), walk-ins, or have been sold. This is necessary to help deter gun thefts.
6. **All sold firearms must have a receipt with the serial number listed.**
7. All ammo must be boxed or cased. Loose cartridges are not allowed on tables. Any dummy rounds must have primers removed and holes drilled through the side.
8. Knives must be sheathed unless they are not readily accessible by the public. Glass display cases or a 6" height minimum perimeter barrier is required to display knives.
9. **NO ALCOHOLIC BEVERAGES OR RECREATIONAL DRUGS ALLOWED ON THE PREMISES.**
10. Minors under 18 must be accompanied by an adult.
11. No audio or visual equipment may be used without permission of the gun show management.
12. Show Security reserves the right to inspect any packages, containers or personal belongings entering or leaving the show.
13. All self-defense spray must be in sealed packages.
14. **No Black Powder** is allowed on the show premises. Vendors may display up to 20 – one-pound containers of smokeless gun powder on tables only. Containers larger than one pound are not allowed in the show but may be kept in personal vehicles. No containers of gun powder are allowed under any tables.
15. All lasers and stun devices, except for demos, must have the battery removed or not be readily available to the public.
16. Vendors must adhere to vehicle parking guidelines and **do not park anything in RV spots or designated Kitchen Staff spots.** All RV's must park in designated RV parking and pay a parking fee if spending the night. Arrangements can be made for overnight RV parking by calling Linn County Expo.
17. Vendors must occupy tables and may not sublet. All individuals occupying the space must wear badges while in the gun show.
18. Vendor contents must be primarily firearm or sportsman related unless approved by ARPC Management.
19. Personal pets are not allowed except for service dogs and miniature horses.
20. ARPC strives to provide 24-hour security from Friday at 7PM through Sunday at 3:30PM, however, ARPC is not responsible for the loss of any merchandise or personal items by the exhibitor.

21. Walking isles must be kept clear during the open hours of the show.
22. *Failure to keep your table space occupied and open for business during the open hours of the show, without Management approval, will result in loss of your space at future shows and will result in rent forfeiture. ARPC reserves the right to move or replace vendor positions for the betterment of the show.*
23. *If your area is significantly messy or cluttered when you depart from the show, you will be charged \$100 cleaning fee.*

Information

1. Setup for the show is Friday, 10AM to 7PM and Saturday at 7AM until show opening at 9AM.
2. The Gun Show is open to the public from 9AM to 5PM Saturday and 9AM to 3PM Sunday. Vendors will be allowed in the building at 7AM Saturday and Sunday.
3. Donuts and coffee will be available in the front lobby at 10AM Friday and 8AM Saturday and Sunday.

Firearm Transfers Under Oregon SB941

Firearm transfers have not changed under Oregon SB941 for gun shows. According to an OSP information sheet highlighting the “Oregon Firearms Safety Act”:

“A private party transferring a firearm **at a gun show** must complete a background check through OSP or a firearm dealer prior to the transfer. (NOTE: This is existing statute, however it is highlighted to show the private party has options, in these instances.)”

Please follow the Oregon State Statutes when transferring a firearm at our gun show. Failure to properly transfer a firearm will result in loss of your tables, a call to OSP reporting the infraction, and immediate removal from show grounds. ARPC will have a phone, the Private Party Transfer Forms OSP-WBBN2000 (11/13) (White Private Party Forms) and assistance to anyone who needs help in transferring a firearm at the ARPC vendor table.

Packing up Early

ARPC Gun & Sportsman Show closes at 5pm on Saturday and 3pm on Sunday to the public. Any Vendor packing up early will forfeit their placement at the following Gun show.

Next ARPC Gun & Sportsman Show – March 26th & 27th, 2027

Next show’s vendor applications will be made available on Sunday morning. If you are interested in attending this show, fill out the application and bring payment for your tables to the vendor check-in table before 3:30pm on Sunday. **Discounted table rate is good through the last day of this March 2026 show at 3:30PM only.** We fill up quickly with a waiting list two months prior to the show. If we do not receive your application, you will not receive a reminder phone call.
