### **ARPC 65th Anniversary 1911 Pistol - Available Now**

Now available... the Albany Rifle and Pistol Club 65<sup>th</sup> Anniversary 1911 pistol for members to order. This special handgun is the Remington R1 enhanced 1911 semi-automatic in 45 caliber made in the USA. We understand that Remington quit producing 1911 handguns after WWII and has just recently started producing them again.



Special features include black oxide finish, lowered ejection port, extended beavertail, competition hammer, adjustable rear sights, fiber optic front sight, adjustable trigger and two eight round magazines. Each gun has special Albany Rifle and Pistol Club 65<sup>th</sup> Anniversary medal in the grips (picture not available at time of this edition) and a lifetime replacement. ARPC member cost - \$800 plus firearm transfer. We plan on having these special 1911's available through the end of 2012 or as long as quantities last. Check in at the Pro Shop for details.

### **Hunter Sight-In Days**

How many hunters have missed elk (like the one mounted in our clubhouse) or deer because their rifle was not sighted in properly? Or worse yet, how many animals suffered from a poor shot that failed to take them swiftly?

Albany Rifle and Pistol Club is expanding our 'Hunter's Sight-In Days' this year to three weekends from 9am to 4pm each day; September 8<sup>th</sup>,9<sup>th</sup>,15<sup>th</sup>,16<sup>th</sup>,22<sup>nd</sup> and 23<sup>rd</sup> to help sight in more hunter's rifles. We will be expanding the advertising and reaching out to hunters with the message about making sure their rifles are sighted in correctly and ready to go for the upcoming season. With this expanded effort we will need your help to make sure we can handle the expected increase in sight-ins. ### **Main Range Building Overhaul - Continuing**

We have replaced the old shedding vapor barrier (new vapor barrier is rated at 19db noise reduction). While this barrier reduces sound passing through, it has a tendency to reflect sound back into the main range. Therefore, we have noticed an increase in the volume level. The sound absorption panels are currently being installed and will alleviate this problem. The new lighting has been ordered and will be installed as soon as time permits. Fortunately with the long summer days, this isn't a problem right now. We thank you for your patience and understanding while this project takes place and the main range should be much nicer by this fall.

# Disinformation Continues as U.N. Arms Treaty Takes Shape - Update



To all club members. Please read the following excerpt from NRA-ILA posting about the proposed U.N. Arms Treaty. This is a direct quote from the NRA website. If you are as fired up about this issue as we are, we would recommend that you send a fax or letter to both of our Senators in Washington D.C. and any other Senator you want to send a message to. Forget emails, they get dumped by the hit of a button. If this is important to you then ACT! We are a sovereign nation with our own laws and will not be regulated by world-wide government whether it concerns firearms or any of our other rights!

"In New York this week, the U.N. Conference on the Arms Trade Treaty continued trying to draft a treaty to impose worldwide controls on small arms, including civilian-owned firearms.

The NRA has made clear its opposition to any treaty that includes civilian firearms, and continues to note that a majority of the United States Senate stands with American gun owners in opposition to such a treaty. We have led the effort to mobilize opposition to the treaty in Congress, and not only a bipartisan majority of the U.S. Senate, but also 130 House members, have voiced strong opposition to the treaty. Ignoring that reality, U.N. conferees are working to regulate not only civilian small arms, but also ammunition and firearm parts.

Anti-gun treaty proponents continue to mislead the public, claiming the treaty would have no impact on American gun owners. That's a bald-faced lie." For more information <u>click here</u>.

## **North Range Target Stands**



We have mentioned this issue in our newsletter many times over the last year or two but it keeps raising its ugly head with club members.

Here are the facts:

Two years ago we initiated a program to provide metal target stands in all shooting bays on the north and east ranges. To date, we have lost 30 target stands to theft. We make repairs on an average of 15 shot up stands a month. We also notice stands moving between bays and not returned to their proper place. These issues have caused complaints by club members and we understand.

Remember "always leave the range in better shape than you found it" and put your stands back if you borrowed them from another bay. Do not remove target stands from the club property, that equals theft. Hang stands up when you finish shooting so they don't get 'accidentally' shot. Please think about your fellow members and the club.

If you have a complaint, comment or suggestion, please let someone in the club office know about it. Let us know if you find something missing or broken on the range. 4229 When we know about a problem, we can get it fixed right away.
