## Remington Arms Recall

Remington Arms announces a voluntary recall on Model 700 and Model Seven rifles with the X-Mark Pro triggers, manufactured from May 1, 2006 to April 9, 2014. Senior Remington engineers determined that some Model 700 and Model Seven rifles with XMP triggers could, under certain circumstances, unintentionally discharge. Remington established a dedicated website and

toll-free hotline to help consumers determine whether their rifle(s) are subject to recall. 1-800-243-9700 (prompt #3 then prompt #1)
