#### **[HB2543 Updates](#) - Hearing Scheduled**

UPDATE 3/1/21: HB 2543 is scheduled for Public Hearing on 3/4/2021 at 1 pm. HB2543's agenda item starts at 1:50pm. This bill enables rejection of a firearms

purchase by delaying or just not completing background checks. This infringes upon law abiding citizen's 2nd amendment rights, while having no effect on criminals. Current laws at state and federal level require authorities to uphold their responsibility to respond within 3 days.

### **SB554-A Update - Act Now! - Bad Legislation - Voted Out of Committee**

UPDATE 2/25/21: SB554 has been voted out of committee and is headed to the floor.

- SB554 been amended "-10 amendment" proposed to attempt to fix glaring problems but they have only made it worse for public safety. Not only does this bill remove CHL holders from public buildings thus creating gun free zones where history has shown that >95% of criminal mass events occur, it forces law abiding citizens to stow their firearms in vehicles as a matter of practice to avoid from becoming a felon. This is just bad legislation.
- The Senate Majority continues to categorize our law abiding citizens, as extremists, which is just not the case ([see the press release](#)). Oregon gun owners, sportsmen, and CHL holders which this bill targets specifically are responsible reasonable and valued parts of our community.
- Unfortunately, the committee chairman is ignoring public testimony with the solid data and is proceeding with the agenda to remove Oregon citizen's right to keep and bear arms.
- Your Action is needed!
- Contact your Senators and Representatives to let them know that this legislation needs to stop,
  - LEARN: Review the materials OSSA has posted on this page
  - DECIDE: Conclude what this means for you, your family, and your grandchildren.
- COMMUNICATE:
  - You are one of their voters!
  - This is bad legislation it makes felons of their most lawful citizens.
  - Show your legislators that you are the responsible citizens they represent.
  - Be Polite - but Firm!

## 5 Stand

Starting March 13th 5 Stand is Back on! 5 Stand Consists of 5 shooting stands and 5 target opportunities at each stand. First time through you get a single bird that you can shoot at a second time if you miss with your first shot. Next time through a report pair, the second bird is thrown at the report of your first shot and on the third time through a true pair will be thrown. Then everyone moves to the next station and the process is repeated until everyone has shot at each station.

There will be 5 throwers set up, a tower bird from over your back, an incoming bird, a left to right crossing bird, a right to left crossing bird and a chondel (a looping target). The throwers are numbered and there is a menu posted at each station. There is a different menu at each stand. ## JR. TRAP PROGRAM

ARPC has many programs available for members and non-members and we are proud to say that one of them is Jr. Trap. This program has evolved over the years and a couple of years ago we joined forces with 4-H and that move has proved to be a valuable asset to the program. The Jr. Trap Program is open to kids ages 9-18 (they must have the strength and ability to hold a shotgun safely and fire it). The kids are coached by Dave Imel, Dir. Jr. Trap, and he is assisted by Tim Austin. Dave is also a

certified 4-H Shotgun Leader and he has two other parents, DeAnna Cormany and Amber Beck who are also Shotgun Leaders and they are a great help in keeping this program running and Chip Cover, Trap Dir., who comes and helps Dave when teaching Five Stand and keeping the equipment running.#13871

In Jr. Trap the kids are taught how to handle a shotgun safely, sportsmanship, learn the basics of shooting trap, doubles and five stand. If your son or daughter likes a challenge then this is a program for them, they will be trying to hit a small orange disc that flies at approx. 40 miles per hr. around 60-70 yds out and you don't know which direction it will be flying until it comes out. Because it is a challenge, we are looking for kids who are serious about learning to shoot and want to come to practice. Practice is held every Saturday and at present we have two start times because of the number of kids shooting.

This program wouldn't be successful without the dedicated parents who bring the kids to every practice and help when asked and the kids who want to be there and improve their shooting skills. I would also like to thank the ARPC Board and Brian Boesch, without them this program wouldn't exist.
